- **Personal Data:** Information that identifies or can be used to identify an individual.

- **Service Provider:** A third-party company or individual we employ to help us provide or analyze the Service.
- **Usage Data:** Information automatically collected about your Service usage, such as IP address and visited pages.

Collecting and Using Your Information

Types of Data We Collect:

We may disclose your Personal Data in various situations, including:

Our Service does not address anyone under 13. We do not knowingly collect Personal Data from users under 13. If you learn your child has provided us with Personal Data, please contact us for immediate action.
