# 1. Introduction and Acceptance

This document outlines the terms and conditions ("Terms") governing your purchase, use, and installation of our products.

- Maintaining products following our guidelines.

Any deviations from these standard conditions must be documented and agreed upon by all parties involved, including Kent Global, the Buyer, and, if applicable, the installer.

#### 3. Disclaimer of Warranties

Kent Global makes no express or implied warranties regarding:

- Suitability of products for specific uses.
- Installation procedures.
- Maintenance practices.
- Aesthetic consistency of natural stone products.

By installing or using any product, the Buyer waives all claims, including warranties of merchantability and fitness for a particular purpose. Kent Global is not liable for any indirect, special, punitive, incidental, or consequential damages arising from product ownership, use, possession, or maintenance. Our liability in any dispute is limited to replacing the product(s) with account credit or a full refund, at our discretion.

#### 4. Prices and Terms of Sale

Kent Global reserves the right to modify prices, terms, and conditions of sale without prior notice. All prices are quoted ExWorks from our warehouse (Incoterms 2022) unless otherwise specified. Title to the products transfers upon purchase, but the risk of loss remains with the Buyer until delivery.

## 5. Payment Terms

Payment methods and terms may vary. Common options include:

- Cash on delivery (COD)
- Credit card processing
- Net terms for qualified accounts (subject to credit approval)

Past-due invoices will incur interest charges and other fees. Kent Global reserves the right to revoke credit privileges and cancel orders for non-payment.

## 6. Order Acceptance and Changes

Kent Global reserves the right to accept or reject orders at our sole discretion. Order modifications or cancellations after order confirmation may be subject to fees.

## 7. Delivery

Kent Global will arrange delivery upon confirmation and payment for the order. Delivery timeframes are estimates and may vary depending on location, product availability, and shipping methods. The Buyer is responsible for inspecting the delivered products upon arrival. Report any damage claims within 48 hours of delivery to the carrier and Kent Global. Failure to comply may affect claim resolution.

### 8. Return Policy

Returns may be authorized on a case-by-case basis, subject to the following conditions:

- Authorization must be obtained from Kent Global before returning any products.
- Returns must be initiated within a specified timeframe (e.g., 30 days) from the invoice date.
